Beekeeping experience

Hello my name is Barry Hantz from Hantz Honey, I am a third-generation commercial beekeeper. Hantz Honey has been in the business of beekeeping for 75 years, with myself having worked in the family business over the last 25 years. I started in the business at the bottom - working beehives and learning the ropes... safe to say that after 25 years ...I am fully qualified and suitably experienced in all aspects of commercial beekeeping and running a successful beekeeping operation (although there have been a few memorable moments along the way!). Currently we are running around 5000 beehives (double brood nests) through-out Ellesmere, Darfield, Rakaia and Dorie Pendarves. We are the second largest beekeeping operation In Canterbury. Predominately, we are clover honey producers on the Canterbury Plains, we do have some beehives on Manuka, up at Springfield. We have been producing comb honey for many years and it's one of our specialty lines. Our other main income is from pollination – we provide bees to pollinate blackcurrants, blueberries, small seed crops like radish, onions, pak choi through to canola, chickery and carrots. We also do some cage pollination using nucs. We sell honey domestically and export, offer contract extraction and packing services, produce our own queens and sell queens domestically. We employ 15 staff to run our operation. As you can see there's a bit going on!

My goal is to develop a united bee industry group which is highly functional, achieving solid outcomes for the beekeeping industry and financially sustainable. To provide valuable input into the HBNZ board through the knowledge and experience I have gained in past roles and initiatives. Together with my wife Rose, we run our 1600 hive family business, employing two full time additional team members in the Eastern Bay of Plenty region. We specialise in bulk honey production and Kiwifruit pollination, with beeswax and propolis supply being additional, more minor, areas of our production.

I have been fulltime commercial beekeeping for 30 years now, I am a second generation beekeeper with lifelong exposure to the beekeeping industry, and my interest in beekeeping grew with more involvement in my parent's apiary business. In the early 2000's I also spent 2 seasons in Alberta, Canada, working for a large commercial beekeeper, and I continue to take interest in what is happening within the beekeeping industry in various countries to keep aware of industry innovation and concerns internationally.



I often attend, and occasionally help organise, our local regional industry field days, at times traveling further afield to also keep up to date. Julian McCurdy

Beekeeping experience

I've grown to be General Manager of Forest & Bees Native Honey and have been involved in commercial honey production, operations and export specifically since 2019. My work here covers the practical realities of commercial beekeeping: hive operations, queen and stock performance, crop planning, extraction, testing, inventory, logistics, staff, customers, compliance and commercial decision-making.



We are approximately 670 hives currently, we use annual acquisition and splits to get to 800+ hives, with an additional 700-hive joint venture type hive placements for the 2027 season. We go hard for Mānuka in Taranaki and try each season for more consistent performance while operating in a very dynamic ecosystem. Before Forest & Bees, my experience with bees, beekeeping, apiculture business systems and beekeeping technology started in 2010 through BeezThingz and since 2016 through BuzzTech.

I've trained and supported six apprentices to accreditation with another 2 ongoing, including 2 women through Level 4. I have also led queen cohort work, Varroa Sensitive Hygiene selection strategies and built VSH tracking into BuzzTech app workflows. This gives me a bottom-up and top-down view of the industry: from apiary work, bee health and genetics through to technology, export, compliance, business management, chemistry, sales and industry strategy.

What you would bring to the Board

I'm interested in the short-term Board role because the industry has reached a pivotal point that shows real hope. HBNZ needs clear priorities, reliable information flows, practical member engagement and decision systems that turn frustration into action. I want to help bring systems discipline to the room: define the problem properly, connect the right people, use evidence, measure progress and keep the focus on outcomes for commercial beekeepers.

My strongest contribution would be whole-system thinking backed by practical execution. I can connect field reality, commercial pressure, technology, training, regulation, science, export requirements and member needs into plans that people can use. I bring experience building businesses, products, teams and workflows; raising and deploying capital; improving processes; managing risk; and translating complex technical issues into plain-language decisions.
